BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those easement deeds of RBD, INC., a California corporation, and GENSTAR DEVELOPMENT, INC., a New York corporation, executed in favor of The City of San Diego, bearing dates of June 2, and June 3, 1980, respectively, conveying to said City easements for public street, water and drainage purposes, over, under, upon, along and across that portion of Parcel 3 & 4 as shown on Page 8071 of Parcel Maps, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and Parcel A is hereby named PASEO LUCIDO, and Parcel B is hereby named BERNARDO HEIGHTS PARKWAY.

That the City Clerk is hereby authorized and directed to cause said deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
