BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of FREDERICK W. HAMPE and RAYMOND H. HAMPE, as Trustees of Trust A & B per Will of Harry Hampe, deceased, executed in favor of The City of San Diego, bearing date of September 16, 1980, granting to said City a permanent easement and right of way for public street and incidents thereto through, over, under, upon, along and across a portion of the Southeast quarter of the Northeast quarter of Section 12, Township 14 South, Range 3 West, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named STARGAZE AVENUE.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
