BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by SAMUEL F. SAFINO, a Registered Civil Engineer, entitled "KOLL - MISSION VALLEY Being a subdivision of portions of Lots 1, 2, 3 and 4 of Plat of Lot 32 and part of Pueblo Lot 1113 according to Map thereof No. 875, together with a portion of Lot 31 of the Partition of Rancho Mission of San Diego, made in an action entitled 'Commercial Bank of San Diego vs. Juan M. Luco, et al,' on file in the office of the County Clerk, all in the City of San Diego, County of San Diego, State of California.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council,


