WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated has been superseded by a new street; and

WHEREAS, that portion of Prestress Way has been superseded by a new street, Marindustry Place, being dedicated with the acceptance of the final map of the subdivision to be known as Miramar Place Tract Unit No. 1; and

WHEREAS, those properties adjoining that portion of Prestress Way to be vacated will continue to have access or will be accessible by the street which has been dedicated with the approval on this date of the subdivision to be known as Miramar Place Tract; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That a portion of Prestress Way, as more particularly shown on Drawing No. 14558-B on file in the office of the City Clerk as Document No. RL-252924, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

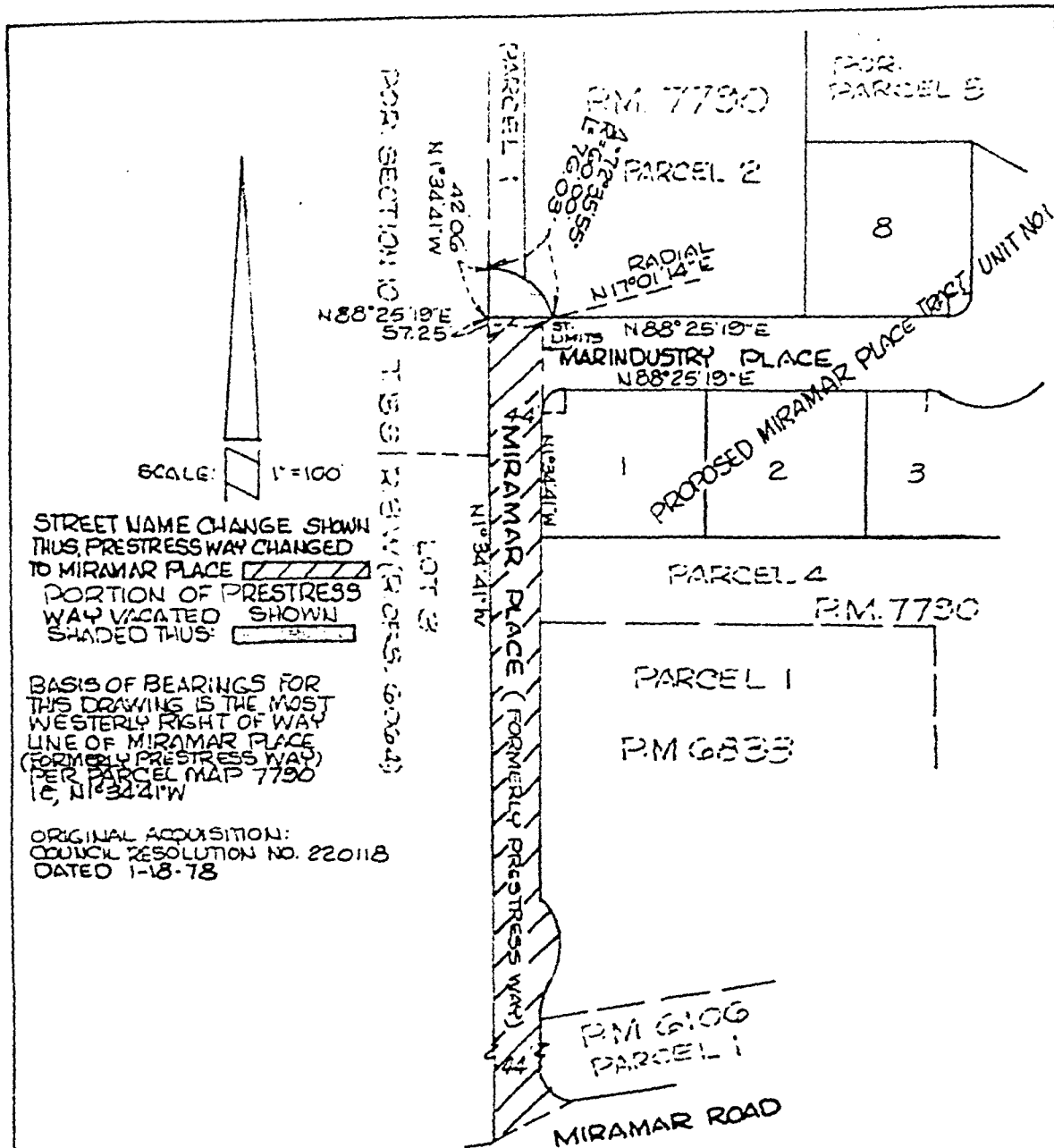
2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.



