A RESOLUTION OF PRELIMINARY APPROVAL OF ENGINEER'S REPORT

CAMINO DEL RIO SOUTH, TEXAS STREET TO I-805
ASSESSMENT DISTRICT

RESOLVED, by the City Council of the City of San Diego,
California, that

WHEREAS, on the 27th day of October, 1980, said Council did adopt its Resolution No. R-252941 Preliminary Determination and of Intention to construct improvements in said City, and did refer the proposed improvements to the Superintendent of Streets, he being the officer having charge and control of the construction of public improvements in and for said City of the kind described therein, being a competent person employed by said City for that purpose, and did therein direct said Superintendent of Streets to make and file with the City Clerk of said City, a report, in writing, all as therein more particularly described, under and pursuant to the Municipal Improvement Act of 1913, Division 12 of the Streets and Highways Code of the State of California;

WHEREAS, said Superintendent of Streets has made and filed with the City Clerk of said City a report, in writing, as called for in said Resolution of Preliminary Determination and of Intention and under and pursuant to said Act, which report has been presented to this Council for consideration; and

WHEREAS, said Council has duly considered said report and each and every part thereof, and finds that each and every part of said report is sufficient, and that neither said report, nor any part thereof requires or should be modified in any respect;

NOW, THEREFORE, IT IS ORDERED, as follows:

1. That the plans and specifications for the proposed improvements to be made, contained in said report, be, and they are hereby preliminarily approved.

2. That the Engineer's estimate of the itemized and total cost and expenses of said improvements and of the incidental expenses in connection therewith, contained in said report, be, and each of them are hereby, preliminarily approved.

3. That the diagram showing the assessment district referred to and described in said Resolution of Preliminary Determination and of Intention and also the boundaries and dimensions of the respective subdivisions of land within said assessment district as the same existed at the time of the passage of said Resolution of Preliminary Determination and of Intention, each of which subdivisions has been given a separate number upon said diagram, as contained in said report, be, and it is hereby, preliminarily approved.

4. That the proposed assessments upon the several subdivisions of land in said assessment district in proportion to the estimated benefits to be received by such subdivisions, respectively, from said improvements, and of the incidental expenses thereof, as contained in said report, be, and they are hereby, preliminarily approved.

5. That said report shall stand as the Engineer's Report for the purposes of all subsequent proceedings had pursuant to said Resolution of Preliminary Determination and of Intention.
