A RESOLUTION APPOINTING TIME AND PLACE OF HEARING
PROTESTS IN RELATION TO PROPOSED ACQUISITIONS
AND IMPROVEMENTS AND DIRECTING NOTICE

CAMINO DEL RIO SOUTH, TEXAS STREET TO I-805
ASSESSMENT DISTRICT

RESOLVED, by the City Council of the City of San Diego,
California, that

WHEREAS, pursuant to Resolution No. R- 252941 of Preliminary
Determination and of Intention adopted on October 27, 1980, by the
City Council of said City pursuant to the Municipal Improvement Act of
1913, Division 12 of the Streets and Highways Code and Section 19 of
Article XVI of the Constitution of the State of California, the
Superintendent of Streets of said City has filed with the City Clerk of
this City the written report called for under said Act and by said
Resolution of Preliminary Determination and of Intention, which report
has been presented by said Clerk to this Council for consideration, and
this Council has considered and preliminarily approved said report and
ordered that the same stand as the report for the purpose of all
subsequent proceedings had pursuant to said Resolution of Preliminary
Determination and of Intention;

NOW, THEREFORE, IT IS ORDERED, that Tuesday, the 3rd
day of February, 1981, at the hour of 8:30 o'clock a.m., in the
regular meeting place of said Council, Council Chambers, City
Administration Building, 202 "C" Street, San Diego, California, be, and
the same are hereby, appointed and fixed as the time and place when and
where the Council will consider and finally determine whether the
public interest, convenience and necessity require said improvements,
and when and where it will consider and finally act upon the Engineer's
Report under said Resolution of Preliminary Determination and of
Intention.

IT IS FURTHER ORDERED that the City Clerk of this City be, and he is hereby, directed to give notice of said hearing once a week for two weeks in the San Diego Daily Transcript, a newspaper published and circulated in the City of San Diego, and by conspicuously posting a notice thereof along all the open streets within the assessment district at not more than three hundred feet apart, and not less than three in all; said posting and first publication to be had and completed at least twenty (20) days before the date herein set for hearing of protests.

IT IS FURTHER ORDERED that said notices as posted shall be headed "Notice of Improvement" in letters of not less than one inch in height and said notices shall, in legible characters, state the fact and date of the passage of said Resolution of Preliminary Determination and of Intention and of the filing of said report and of the date, hour and place set for the hearing of said protests, briefly describe the improvements proposed to be made, and refer to said Resolution of Preliminary Determination and of Intention and report for further particulars.

IT IS FURTHER ORDERED that the City Clerk of said City shall mail, or cause to be mailed, notice of the adoption of said Resolution of Preliminary Determination and of Intention and the filing of said report, postage prepaid, at least twenty (20) days before the date set for hearing of said protests, to all persons owning real property to be assessed, whose names and addresses appear on the last equalized assessment roll prior thereto or as known to the City Clerk, which notice shall contain a statement of the time, place and purpose of the hearing on said Resolution of Preliminary Determination and of Intention and report and a statement of the total estimated cost of the proposed improvements, the total amount as shown by said report to be assessed against the particular parcel covered by the notice, together with a statement that any person interested may file a protest, in writing, as provided in said Act.
