A RESOLUTION CALLING FOR BIDS ON SALE OF IMPROVEMENT BONDS,  
APPROVING NOTICE OF SALE AND AUTHORIZING AND  
DIRECTING CERTAIN ACTIONS WITH RESPECT THERETO

CAMINO DEL RIO SOUTH, TEXAS STREET TO I-805  
ASSESSMENT DISTRICT

RESOLVED, by the City Council of the City of San Diego,  
California, that

WHEREAS, the City Clerk of said City is hereby directed  
to call for bids for the sale of Improvement Bonds to be issued  
pursuant to Resolution No. R- 252941 of Preliminary Determination  
and of Intention, adopted by this Council on October 27, 1980;

WHEREAS, pursuant to this Council's authorization, there  
has been prepared and presented to this Council a Notice of Sale  
of the Improvement Bonds;

NOW, THEREFORE, IT IS ORDERED, as follows:

1. The Notice of Sale is approved for distribution in the  
offering and sale of not to exceed \$846,254.34 of Improvement  
Bonds.

2. The City Clerk is authorized and directed to execute  
the Notice of Sale on behalf of this City and this Council and  
to call for bids for the sale of the Improvement Bonds, such  
bids to be received on February 2, 1981, all in the manner more  
particularly set forth in the Notice of Sale.

3. The City Clerk is also authorized, in executing the  
Notice of Sale and Official Statement, to approve further correc-  
tions and additions therein by supplement or amendment thereto, or  
otherwise as appropriate, provided that any such corrections or  
additions shall be necessary to cause the information contained  
therein to conform to the proceedings of this Council or such  
corrections or additions are in form rather than in substance.

4. The City Clerk is authorized and directed to cause the Notice of Sale to be distributed to such municipal bond broker-dealers, to such banking institutions and to such other persons as may be interested in purchasing the Improvement Bonds therein offered for sale.

5. The City will furnish the legal opinion of the law firms of Luce, Forward, Hamilton & Scripps and Wilson, Morton, Assaf & McElligott, unqualifiedly approving the legality of the proceedings and the issuance of the Improvement Bonds.
