BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Mayor and City Clerk are hereby authorized and empowered to execute a quitclaim deed, quitclaiming to MERCY HOSPITAL AND MEDICAL CENTER, SAN DIEGO, all the City's right, title and interest in an unneeded public utilities easement, as more particularly described in that quitclaim deed on file in the office of the City Clerk as Document No. RC 252958 - 1.

That said easement is unneeded because all necessary or desirable utilities can be most appropriately located in available street right of way.

That the City Clerk of said City is hereby authorized and directed to deliver said deeds, and a certified copy of this resolution to the Engineering and Development Department for further handling.
