2. Authorizing the Manager's Office to accept the grant when tendered.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$35,000 from Fund 18516, Department 5970, Organization 70016 Program Year Contingency to Fund 18516, Department 5971, Organization 7103 (Small Business Assistance Program) to be used as City Matching Funds.
