That the City Manager be and he is hereby authorized and empowered to pay the sum of \$23,012.45, in addition to \$4,500.00 already expended, in the settlement of each and every claim against The City of San Diego, its agents and employees, resulting from property damage to Oliver A. Gill.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue three checks totaling \$23,012.45: one check to the contractor doing the repairs, in the amount of \$18,140.45, made payable to A & J CONSTRUCTION COMPANY; one check not to exceed \$3,000.00, made payable to OLIVER A. GILL, for damaged personal property; and one check not to exceed \$1,872.00, made payable to A & J CONSTRUCTION COMPANY; in full and final settlement of all property damage claims of Oliver A. Gill.
