That the City Manager be and he is hereby authorized and empowered to pay the sum of \$18,448.35, in addition to \$4,500.00 already expended, in the settlement of each and every claim against The City of San Diego, its agents and employees, resulting from property damage to H & W Building Co. and National SemiConductor.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue three checks totaling \$18,448.35: one check to the contractor doing the repairs, in the amount of \$15,038.15, made payable to A & J CONSTRUCTION CO.; one check not to exceed \$1,000.00, made payable to H & W BUILDING CO.; and one check, in the amount of \$2,410.20, made payable to NATIONAL SEMICONDUCTOR; in full and final settlement of all property damage claims of H & W Building Co. and National Semiconductor.
