

RESOLUTION NO. R-252991Adopted on OCT 28 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

| <u>NAME</u>      | <u>DEPARTMENT</u>   | <u>AMOUNT</u> | <u>SUGGESTION</u>  |

| Edward J. Zitter | Police              | \$ 160        | Mr. Zitter is a Sergeant. He suggested that juvenil offenders' index numbers be prefaced with their year of birth. This is expected to save \$1,049 annually in purging costs. This is a partial award pending a final 12-month review.  |
| Lee R. Noorda    | Property            | \$ 140        | Mr. Noorda is an Electrician at the San Diego Stadium. One year ago he earned a \$50 partial award with his suggestion to replace eyebrow lights with vandal proof fixtures of unbreakable plastic. The first year's savings as a result of his suggestion were \$1,906. This is the remainder of his award. |
| Charles L. Mills | Building Inspection | \$ 130        | Mr. Mills is a Senior Housing Inspector. He suggested that a general inspector be assigned to make all of the inspections within a mobilehome park. One year's actual savings was \$1,284.   |
| Delmar C. Miller | Park and Recreation | \$ 125        | Mr. Miller is a Utility Supervisor in the Central Division. He suggested that chipper blades be sharpened by an outside contractor. This saves an estimated \$420 annually.  |
| Terri M. Holt    | City Clerk          | \$ 120        | Ms. Holt is an Intermediate Typist. She suggested that a rubber stamp be used to certify copies made in the City Clerk's Office. This saves an estimated \$401 annually in processing costs.   |
