WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Abel Hernandez	Water Utilities	\$ 95	Mr. Hernandez is a Waste Water Plant Lead Operator in the Quality Division. He suggested that a photoelectric switch be installed to automatically operate outside lights at the Pt. Loma Plant. The estimated annual savings are \$320 in energy costs.
Beverly M. Bacon Jeanette H. VanLoon	Personnel	\$ 90	Ms. Bacon and Ms. VanLoon are Intermediate Typists. They suggested that a standardized form replace the eligibility card when processing payroll change notices. This is expected to save \$302 annually in processing costs.
Rick Cumming III	Risk Management	\$ 40	Mr. Cumming is the Safety Officer. He suggested that auditor accounting be charged to job order numbers by experiencing rating. This is expected to save \$130 annually in processing costs.
Vincent DeLeva	General Services	\$ 30	Mr. DeLeva is an Electrician Supervisor in the Communications and Electrical Division. One year ago he suggested the relocation of a street light to prevent continual damage. One year's experience has shown additional advantages. This is the remainder of Mr. DeLeva's award.
Aaron T. Foust	Fire	\$ 25	Mr. Foust is a Fire Fighter. He suggested that flood lights be installed on wildland apparatus to improve driving visibility. Although savings could not be calculated, this was considered to be a significant safety improvement.
