

RESOLUTION NO. R-252991Adopted on OCT 28 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Aaron T. Foust	Fire	\$ 25	Mr. Foust is a Fire Fighter. He suggested that off-road tires be installed on wildland utility vehicles. Savings could not be calculated, but this was considered to be a significant safety improvement.
Howard D. Crosby	Fire	\$ 25	Mr. Crosby is a Battalic Chief. He suggested tha a spray-on degreaser be used by Fire Engineers to keep their fire engines cleaner at stations. Savings could not be calculated, but this was considered to be a significant operational improvement.
David J. Rock	Park and Recreation	\$ 25	Mr. Rock is an Equipment Technician I in the Coastal Division. He suggested that porta-pool channels be removed prior to location changes. This saves \$80 per year in channel replacement costs.
Sylvia L. Johnson	Financial Management	\$ 25	Ms. Johnson is a Senior Clerk. She suggested that the Paratransit Application be revised. Savings could not be shown, but the form is easier to fill out and more easily filed. This was considered to be a significant operational improvement.
Shirley E. LaConta	City Auditor	\$ 20	Ms. LaConta is a Senior Typist. She suggested that programmed typewrit carbon ribbon cartridges be reloaded with new ribbon rather than discard. This saves \$215 annually in material costs.
