Russell I. Skillman	Building Inspection	\$ 20	Mr. Skillman was a Field Representative at the time of his suggestion. He suggested that the City Administration Building's information center sign be revised. Savings could not be calculated, but this was considered to be a significant public information improvement.
Michael D. Shea	Fire	\$ 20	Mr. Shea is a Fire Fighter. He suggested that the parking assignments on the apparatus floor of Fire Station #1 be revised to alleviate congestion. Savings could not be calculated, but this was considered to be a significant safety improvement.
Robert W. Buie	Fire	\$ 20	Mr. Buie is a Fire Fighter. He suggested that additional information be provided in training courses for lifting to avoid back injuries. Savings could not be calculated, but this was considered to be a significant safety improvement.
James L. Burleigh	Fire	\$ 20	Mr. Burleigh is a Fire Fighter. He suggested a change in the automatic garage door opener units for Fire Stations. Savings could not be calculated, but this was considered to be a significant safety improvement.
Martin J. Desmond	Engineering and Development	\$ 20	Mr. Desmond is an Associate Traffic Engineer. He suggested that the lights on the Harbor Drive Bridge over the Switzer Slough be activated. Savings could not be calculated, but this was considered to be a significant safety improvement.
