

RESOLUTION NO. R-253002

(R.81-201)

WHEREAS, by Agreement dated May 23, 1975, between the City and the San Diego Unified School District, the City agreed that the District would "have the right to make such use of Balboa Stadium . . . as would be in the best interests of the public, which shall include the right to raze, remodel, rebuild or restructure Balboa Stadium;" and

WHEREAS, said Agreement provided that that portion of Balboa Park occupied by Balboa Stadium shall be used by the School District "only for park and/or recreation purposes;" and

WHEREAS, the Agreement provided that "no new stadium structure, the cost of which exceeds the amount of \$25,000.00, shall be built without the prior approval of the City Council; and

WHEREAS, the School District has caused Balboa Stadium to be demolished and is now proposing construction of a new stadium which will provide seating for 3,640 spectators at a basic cost of approximately \$1,000,000.00 and has requested Council approval of such new construction; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that reconstruction of Balboa Stadium, together with related improvements as described in that document on file in the office of the City Clerk as Document No. RR-253002, is hereby approved.

BE IT FURTHER RESOLVED, that this approval is contingent upon the reconstructed stadium being utilized solely and exclusively for public park and recreation purposes.
