AMERICAN PROCESSING COMPANY, INC., are hereby accepted; and the City Manager is hereby authorized to execute contracts for HAULING OF DRIED SLUDGE ON FIESTA ISLAND as may be required for a period of nine (9) months beginning approximately November 1, 1980 through June 30, 1981 as follows:

- 1. W.M. ZONDORAK, GENERAL ENGINEERING CONTRACTOR for hauling approximately 24,000 cubic yards of dried sludge on Fiesta Island at a cost of \$0.66 per cubic yard for a total estimated cost of \$15,840.00; terms 1% 10 days, with an option to renew contract for an additional one (1) year period at prices not to exceed 10% of the bid price.
- 2. AMERICAN PROCESSING COMPANY, INC. for hauling approximately 5,000 cubic yards of dried sludge from Fiesta Island to Utilities property adjacent to Brown Field at a cost of \$3.00 per cubic yard for a total estimated cost of \$15,000.00; terms net 20 days, with an option to renew contract for an additional one (1) year period at prices not to exceed 12% of the bid price.


