BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of BURROUGHS CORPORATION is hereby accepted; and the City Manager is hereby authorized to execute a contract for rental of Four (4) Each FACSIMILE EQUIPMENT, and purchase of supplies as required per Schedule II, per prices on file in the Purchasing Department for the period of October 1, 1980 through September 30, 1981; terms net 30 days, plus sales tax with the following options:

1. To add one (1) machine to system approximately October 14, 1980 at Schedule II price;
2. To add three (3) additional machines to system between October 15, 1980 and June 1, 1981 at Schedule II price;
3. To renew contract for two (2) additional one (1) year periods with escalation not to exceed 10% per renewal year;
4. To purchase equipment within (36) month period beginning October 1, 1980 with rental allowance as set forth in Schedule II.
