APPROVING MAP OF GATEWAY CENTER UNIT NO. 1

BE IT RESOLVED, by the Council of The City of San

Diego, as follows:

Said Council hereby finds that that certain map surveyed by ROBERT G. SCHOETTNER, a Licensed Land Surveyor, entitled "GATEWAY CENTER UNIT NO. 1 Being a subdivision of a portion of Parcel 1 of Parcel Map No. 9089, in the City of San Diego, County of San Diego, State of California, according to map filed in the office of the County Recorder of San Diego County, August 28, 1979.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Towne Centre Drive and a portion of La Jolla Village Drive, for public purposes, and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to La Jolla Village Drive, adjacent and contiguous to Lot 1, all as shown on this map within this subdivision.


The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council,
