APPROVING MAP OF PADRE GARDENS CONDOMINIUMS
SUBDIVISION AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S
ASSURANCE OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING
PROGRAM

BE IT RESOLVED, by the Council of The City of San
Diego, as follows:

Said Council hereby finds that that certain map surveyed
by THOMAS F. DEVENING, a Registered Civil Engineer, entitled
"PADRE GARDENS CONDOMINIUMS Being a subdivision of a portion
of Parcel 1, of Parcel Map 8095, filed in the office of the
County Recorder of San Diego County November 28, 1978 as
File No. 78-510408 of official records, a portion of Lot 43
of Rancho Mission of San Diego, Map 330, SCC 348, together
with a portion of San Diego Mission Road as closed and
vacated to public use in the City of San Diego, County of
San Diego, State of California.," is made in the manner and
form prescribed by law and conforms to the surrounding
surveys; that said map and the subdivision of land shown
thereon is hereby approved and accepted; and said Council
hereby accepts on behalf of the public, the following: a
portion of San Diego Mission Road for public purposes; and
said portion of a street is hereby declared to be a portion
of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation,
the easements with the right of ingress and egress for the
construction and maintenance of water and drainage facilities
as granted and shown on said map and subject to the conditions
set forth thereon.



BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, WILLARD and VERONICA SCHMIDT, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of PADRE GARDENS CONDOMINIUMS.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
