
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that certain map surveyed by DON NASLAND, a Licensed Land Surveyor, described as City owned Site 115B in the City of San Diego, County of San Diego, State of California, according to Map No. 214 filed in the office of the County Recorder of said County, is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that the Mayor and City Clerk be, and they are hereby authorized and empowered to execute, for and on behalf of THE CITY OF SAN DIEGO, the certificate of ownership on said final map of Portions of Lots 1 and 2 of C. C. Seaman's subdivision according to map #214 - Filed with County Recorder August 2, 1887 / City owned Parcel 115B, consenting to the preparation and recordation of said map.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego.
