WHEREAS, in connection with the establishment of South San Diego Industrial Park, the City, in 1975, authorized the expenditure of not to exceed \$50,000 Trust Fund 314 for engineering services; and

WHEREAS, such authorization was based upon an agreement entered into by the Economic Development Corporation (EDC) and Southern Pacific Industrial Development Company which specified that the engineering costs for the industrial park would be paid for on a 50/50 basis by E.D.C. and Southern Pacific; and

WHEREAS, the agreement to share engineering costs was the result of the fact that the City owned 26.44 acres of the industrial park land and Southern Pacific owned 22.34 acres; and

WHEREAS, the City subsequently conveyed 6.48 acres of its land to Southern Pacific and Southern Pacific has requested that the City continue to pay the engineering costs on a 50/50 basis; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure of not to exceed \$22.194.44 for engineering work done in connection with the development of South San Diego Industrial Park is hereby authorized and approved.
