

WHEREAS, the 1st Annual 13K Coronado Bridge Run and Walk for Leukemia sponsored by Radio Station KGB as a fund raiser for the Leukemia Society of America, San Diego Chapter, is to be held on Saturday, November 15, 1980; and

WHEREAS, in order to stimulate interest in this event,
Radio Station KGB desires to include the San Diego-Coronado
Bridge as part of the course over which the participants will
walk; and

WHEREAS, the race is to start in the City of Coronado and proceed over the San Diego-Coronado Bay Bridge (herein called "Bridge"), take the National Avenue exit, north on National Avenue, north on 12th and Park Boulevard using the right lane, west on Upas over 163 on the footbridge and through Balboa Park to the vicinity of Federal Building; and

WHEREAS, Assembly Concurrent Resolution 153 requests that the Department of Transportation, State of California (CALTRANS) permit the use of the Bridge on November 15, 1980, for the necessary period of time if requested to do so by the Cities of San Diego and Coronado; and

whereas, Caltrans has accordingly asked the City Council of The City of San Diego to adopt a resolution requesting that Caltrans close or partially close the San Diego-Coronado Bay Bridge to allow for the running of the race; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to Assembly Concurrent Resolution No. 153 and the request by CALTRANS in relation thereto, CALTRANS is hereby requested to close or partially close the San Diego-Coronado Bay Bridge on Saturday, November 15, 1980, to allow for the running of the 1st Annual 13K San Diego-Coronado Bridge Run and Walk for Leukemia.
