- 3. That a broker's commission shall be paid by The City of San Diego if the applicable Municipal Code provisions have been satisfied.
- 4. That the payment of related expenses in accordance with the sale from the proceeds thereof is hereby authorized.
- 5. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
