WHEREAS, the soil conditions in Crest Canyon are highly unstable and will be subject to significant erosion upon the next major rainstorm; and

WHEREAS, additional erosion in Crest Canyon may undermine houses, a public roadway and further impair a private driveway potentially causing substantial property damage; and

WHEREAS, emergency fire and ambulance service have already been cut off from four residences; and

WHEREAS, an interim solution to this erosion problem has been proposed for implementation before the onset of the winter rains in the interest of public safety and necessity; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- That the plans and specifications for the proposed interim solution project are hereby approved and their immediate implementation authorized, said plans and specifications are on file in the office of the City Clerk as Document No. A-00153
- 2. That this Council hereby determines and declares that an emergency situation exists and that the public interest requires immediate steps be taken to control the erosion problem in Crest Canyon to safeguard the property subject to undermining by soil erosion.

- 3. That the requirement for competitive bidding is hereby suspended to allow the immediate undertaking of the interim project and to enable the expeditious protection of endangered property as authorized by Section 94 of the City Charter.
- 4. That the Purchasing Agent is hereby authorized to contract for the execution of the interim project without going through the competitive bidding process.
- 5. That the City Auditor and Comptroller is hereby authorized to transfer the sum of \$72,000 from the Disaster Assistance Fund 39024 to C.I.P. No. 23-547, Crest Canyon Erosion Control Phase I.
- 6. That the City Auditor and Comptroller is hereby authorized to transfer the sum of \$155,000 from C.I.P. No. 90-245, Capital Outlay Unallocated Reserve Fund 30245 to C.I.P. No. 23-547, Crest Canyon Erosion Control Phase I.
- 7. That the expenditure of \$72,000 from C.I.P. No. 23-547, Crest Canyon Erosion Control from Disaster Assistance Fund 39024; \$155,000 from Capital Outlay Fund 30245; and \$26,000 from Environmental Growth Fund 10505, of The City of San Diego, be hereby authorized, solely and exclusively for the purpose of executing the contract and related costs, and authorizing the Auditor and Comptroller, upon the advice of the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

8. That the City Manager is hereby authorized to execute a contract as negotiated by the Purchasing Agent for the immediate implementation of the project.
