VACATION OF A PORTION OF THORN STREET ADJACENT TO LOT 14, BLOCK 4, OSBORN HILL, MAP 1351, AND LOT L, BLOCK 375, OF HORTON'S ADDITION D.B. 13, PAGE 522.

WHEREAS, it is proposed that a portion of Thorn Street adjacent to Lot 14, Block 4, Osborn Hill, Map 1351, and Lot L, Block 375, of Horton's Addition D.B. 13, Page 522 be vacated; and

WHEREAS, there is no present or prospective use for the street either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, California, that a portion of Thorn Street adjacent to Lot 14, Block 4, Osborn Hill, Map 1351, and Lot L, Block 375, of Horton's Addition D.B. 13, Page 522, as more particularly referred to in Resolution of Intention No. R-252624, is unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that a portion of Thorn Street adjacent to Lot 14, Block 4, Osborn Hill, Map 1351, and Lot L, Block 375, of Horton's Addition D.B. 13, Page 522, as more

particularly shown on Drawing No. 14918-B on file in the office of the City Clerk as Document No. CR-25262A, which said Drawing is attached hereto and made a part hereof, be, and the same is hereby ordered vacated.

BE IT FURTHER RESOLVED, that the City hereby reserves from said vacation the permanent right to utilize, operate, maintain, construct and reconstruct, a pedestrian walkway upon, along and across all that portion of the right-of-way as more particularly shown on said Drawing No. 14918-B.

BE IT FURTHER RESOLVED, that the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.

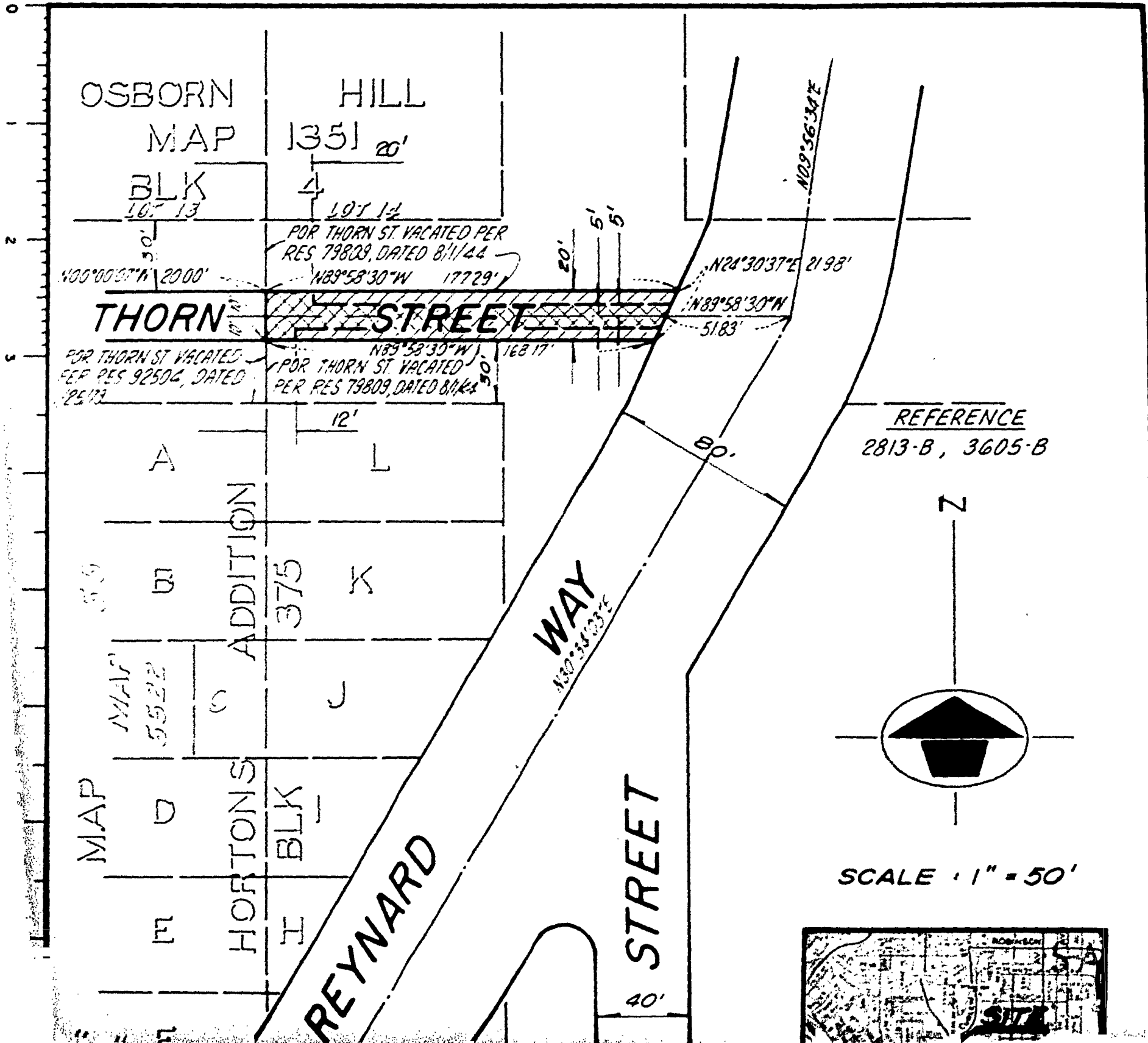

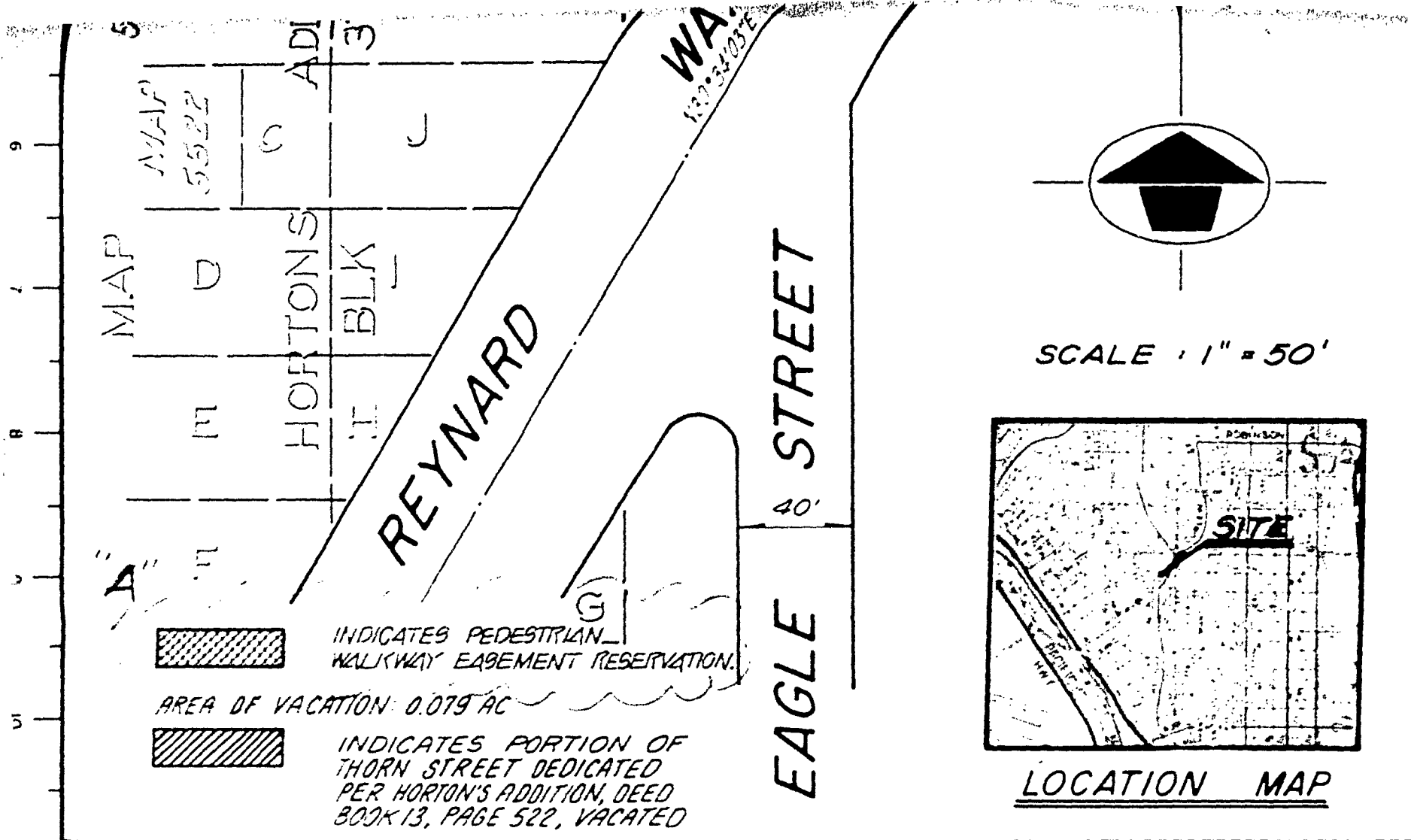
