WHEREAS, Stephen Slepko is the owner of certain real property located at 6503 MacArthur Drive, San Diego, California, and more particularly described as follows:

and

WHEREAS, said real property has been found by the City Engineer to constitute a hazard to public safety, health and welfare by reason of certain land development and fill work having been done without a grading permit in violation of the City's Land Development Ordinance, Section 62.0103 of the San Diego Municipal Code; and

WHEREAS, recent inspection indicates that the fill and land development work, in whole or in part, have closed the mouth of a canyon and natural drainage course and have buried a storm drainpipe; and

WHEREAS, said fill and land development work are considered to represent an extreme hazard and the immediate and total restoration of the canyon is deemed necessary in the interest of public safety; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the real property described above is declared to be a public nuisance.

2. That the real property at 6503 MacArthur Drive constitutes an extreme hazard and the City Attorney is hereby directed to proceed to cause total removal of the fill material.
