BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. FOREMOST THREADED PRODUCTS, 2. WILSON F. CLARK CO., 3. CROWN BOLT & SCREW CORP., 4. WESTERN FASTENER and 5. HAYES BOLT & SUPPLY are hereby accepted; and the City Manager is hereby authorized to execute contracts for furnishing HARDWARE AND FASTENERS as may be required for a period of one (1) year beginning December 1, 1980 through November 30, 1981 per prices on file in the Purchasing Department as follows:

1. FOREMOST THREADED PRODUCTS for Section I (Bolts, pins and washers) and Section IV (Toggle bolts and miscellaneous); terms 1 $\frac{1}{2}$  10 days, plus sales tax with an option to renew contract for a one (1) year period;
2. WILSON F. CLARK CO. for Section II (Nails); terms 2 $\frac{1}{2}$  30 days, plus sales tax with potential first year escalation of 10%;
3. CROWN BOLT & SCREW CORP. for Section III (Machine screws and nuts); terms net 30 days, plus sales tax with an option to renew contract for a one (1) year period;
4. WESTERN FASTENER for Section V (Stainless steel cap screws and nuts); terms 1 $\frac{1}{2}$  10 days, plus sales tax with an option to renew contract for a one (1) year period.
5. HAYES BOLT & SUPPLY for Section VI (Fasteners not otherwise listed); terms 1 $\frac{1}{2}$  10 days, plus sales tax with option to renew contract for a one (1) year period.
