

RESOLUTION No. R-253066 (R.81-844)

Adopted on NOV 10 1980

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of SANTA FE LAND IMPROVEMENT COMPANY, a California corporation, executed in favor of The City of San Diego, conveying to said City the permanent easement and right-of-way for a public street and incidents thereto, over, under, upon, along and across that portion of the northwest quarter of the southeast quarter of Section 11, Township 15 South, Range 3 West, San Bernardino Base and Meridian, according to United States government survey approved February 19, 1883, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and Parcel 1 is hereby named CARROLL ROAD, and Parcel 2 is hereby named MIRAMAR ROAD.

That the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
