Said Council hereby finds that that certain map surveyed by Sydney S. Zinos, a Registered Civil Engineer, entitled "PARK EAST Being a subdivision of Lots 17, 18, 19, 20, 21, and 22 in Block 4 of Pauly's Addition, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 65, filed in the office of the County Recorder of San Diego County on April 1, 1873; together with that portion of the west 10 feet of Mississippi Street adjoining said lots on the east, which was closed and vacated to public use on November 22, 1910, by Ordinance No. 4285, of the Common Council of The City of San Diego., " is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.


The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.
