

RESOLUTION NO. R-253074 (R.81-843)

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, portions of Avenida Magnifica have been relocated by the acceptance on this date of that street easement deed of PONDEROSA HOMES, INC.; and

WHEREAS, the City desires to reserve certain easements for general utilities and open space on those portions of Avenida Magnifica to be vacated; and

WHEREAS, those properties adjoining those portions of Avenida Magnifica to be vacated will continue to have access or will be accessible by the streets which have been dedicated with the approval on this date of the acceptance of that street easement deed of PONDEROSA HOMES, INC.; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That portions of Avenida Magnifica, as more particularly shown on Drawing No. 19333-1-D on file in the office of the City Clerk as Document No. RR-253074-1, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

That the City reserves and excepts from the foregoing vacation general utilities and open space easements, as more particularly shown on Drawing No. 19333-1-D on file in the office of the City Clerk as Document No. RR-253074-1.
