

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with CONTROLTRON CORPORATION to select, install and maintain an accurate flow measurement device and record flows of wastewater pumped to the Point Loma Wastewater Treatment Plant, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-253076.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer within the Sewer Revenue Fund (41506) the sum of \$51,450 from the Unallocated Reserve (70697) to Wastewater General Program Expense (70216) solely and exclusively for the above purpose.
