BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with Pioneer Hook and Ladder Company, a non-profit California corporation, dba THE FIREHOUSE MUSEUM for the purposes of operation and maintenance of an historic fire fighting equipment museum open to the public in a City-owned former firehouse building on Lots 11 and 12, Block 26, Middletown, for a term of five years, at an annual rental of \$1,200, under the terms and conditions set forth in that Agreement on file in the office of the City Clerk as Document No. RR-253078.
