

That the Water Utilities Director or his representative is hereby authorized to travel to Atlanta, Georgia to attend the Energy, Environmental Quality and Natural Resources Steering Committee of the National League of Cities, to be held November 29 through December 1, 1980.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer within the Water Operating Fund (41500) the sum of \$848.00 from the Unallocated Reserve (70669) to Water Utilities Administration (70110) for the sole and exclusive purpose of providing funds for lodging, travel and miscellaneous expenses.
