WYLIE CONSTRUCTION COMPANY for the CONSTRUCTION OF POINT LOMA TREATMENT PLANT BRIDGE CRANE FOR INFLUENT CHANNEL TRASH SCREENS, Base Bid, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. A-00117.
