Being a subdivision of Lot 728 of San Carlos Unit No. 10,
in the City of San Diego, County of San Diego, State of
California, according to the Map thereof No. 5294, filed in
the office of the County Recorder of San Diego County,
November 8, 1963, together with the Alley lying within said Lot
as shown on said Map which was vacated and closed to public
use: also the southerly and the southeasterly 30 feet of
Lynnhaven Lane as vacated and closed to public use by
Resolution No. 202212 recorded in the office of the County
Recorder, March 26, 1971 as File/Page No. 59034 of Official
Records., " is made in the manner and form prescribed by law
and conforms to the surrounding surveys; that said map and
the subdivision of land shown thereon is hereby approved and
accepted.

The Clerk of said City is hereby authorized and directed to
endorse upon said map, as and for the act of the Council, that
said Council has approved said subdivision map.


