APPROVING MAP OF VILLA MADRID AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, a Registered Civil Engineer, entitled "VILLA MADRID Being a subdivision of Parcel 'A,' in the City of San Diego, County of San Diego, State of California, as shown on Parcel 549 of Parcel Maps, filed in the office of the County Recorder of San Diego County, December 12, 1892.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public a portion of 54th Street for public purposes; and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use.



Properties, a limited partnership, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of VILLA MADRID.
