BE IT RESOLVED, by the Council of The City of San Diego as follows:



BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$2127.78 from Subdivision Park Fee Fund 11373; \$40,310.50 from Subdivision Park Fee Fund 14373; and \$16,561.72 from Subdivision Park Fee Fund 14371 for said acquisition and related costs is hereby approved.
