WHEREAS, the Paratransit Monitoring Study was initiated in order to identify and evaluate changes in the Paratransit industry in San Diego as regulations are reformed; and

WHEREAS, since September of 1979, baseline data has been collected, and numerous surveys have been conducted to establish user profiles and service levels; and

WHEREAS, the extension of the Paratransit Monitoring Grant contract period for an additional six (6) weeks, until December 31, 1980, would allow the Project Coordinator to complete implementation of annual surveys and data collection projects which will be in progress during the month of November; and

WHEREAS, no additional UMTA or City funds are requested or required since previous federal funding is sufficient to cover the extension of six (6) weeks requested herein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be, and he is hereby fully authorized to execute, for and on behalf of said City, a SECOND AMENDMENT TO AGREEMENT with VICTORIA M. WHELAN, an independent contractor, to extend the term thereof for a period of six (6) weeks
