WHEREAS, the Comprehensive Planning Organization (CPO) has requested proposals for EPA Section 175 funds; and

WHEREAS, CPO has expressed interest in increasing ride-sharing in the Central Business District of San Diego with an emphasis on promoting ridesharing within the multi-story high occupancy buildings in that area; and

WHEREAS, The City of San Diego will be the lead agency and will be assisted by Commuter Computer and the Chamber of Commerce; and


WHEREAS, this project will be fully funded by EPA, with no cost to be borne by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to prepare and submit a grant proposal for EPA Section 175 funds.

BE IT FURTHER RESOLVED, that the City Manager is further authorized to accept said Grant funds, if awarded, for the purpose of conducting a demonstration project to promote ridesharing within multi-story, high occupancy building areas in the San Diego Central Business District.
