WHEREAS, the State of California has asked for proposals to provide transportation for low mobility persons, such as elderly and handicapped; and

WHEREAS, the State has displayed interest in projects which coordinate and interface with other systems; and

WHEREAS, each project will be fully funded with 620 funds, there being therefore no cost to The City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be, and he is hereby authorized to prepare grant proposals applying for State 620--Discretionary Funds.

BE IT FURTHER RESOLVED, that the City Manager is also authorized to accept said Grant funds, if awarded for the purpose of:

1. Implementation of a coordinated/consolidated social service agency transportation project.
2. Interfacing the San Diego Dial-a-Ride program with other regional systems.
