Mackensie Brown be employed and appointed as special bond counsel for giving an opinion on any bonds that may be issued in connection with the proposed proceedings under the Municipal Improvement Act of 1913 and the Improvement Bond Act of 1915 for the construction of the Mira Mesa Boulevard Project pursuant to the terms and conditions set forth in the SPECIAL COUNSEL AGREEMENT, which is on file in the office of the City Clerk as Document No. RR- 253119 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,000 be hereby authorized out of Federal Revenue Sharing Fund 18009, CIP 58002, to the Special Bond Counsel in the event said project is abandoned.
