BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of HILLSIDE COLONY, a California limited partnership, executed in favor of The City of San Diego, bearing date of October 16, 1980, granting to said City a permanent easement and right-of-way for a public street and incidents thereto, over, under, upon, along and across all that portion of Lot 24, in Fractional Block 12 of Middletown Addition, as more particularly described in said deed, be, and the same is hereby approved; **RR-253150** and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named KEATING STREET.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
