WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where the street to be vacated has been superseded by relocation; and

WHEREAS, portions of McKee Street and India Street have been relocated by the street dedication with the acceptance of a street easement deed of HILLSIDE COLONY, a California limited partnership; and

WHEREAS, those properties adjoining those portions of McKee Street and India Street to be vacated will continue to have access or will be accessible by the street which will be dedicated with the approval on this date of the acceptance of that street easement deed of HILLSIDE COLONY; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That portions of McKee Street and India Street, as more particularly shown on Drawing No. 15185-B on file in the office of the City Clerk as Document No. RR- 253151, which is by this reference incorporated herein and made a part hereof, be, and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

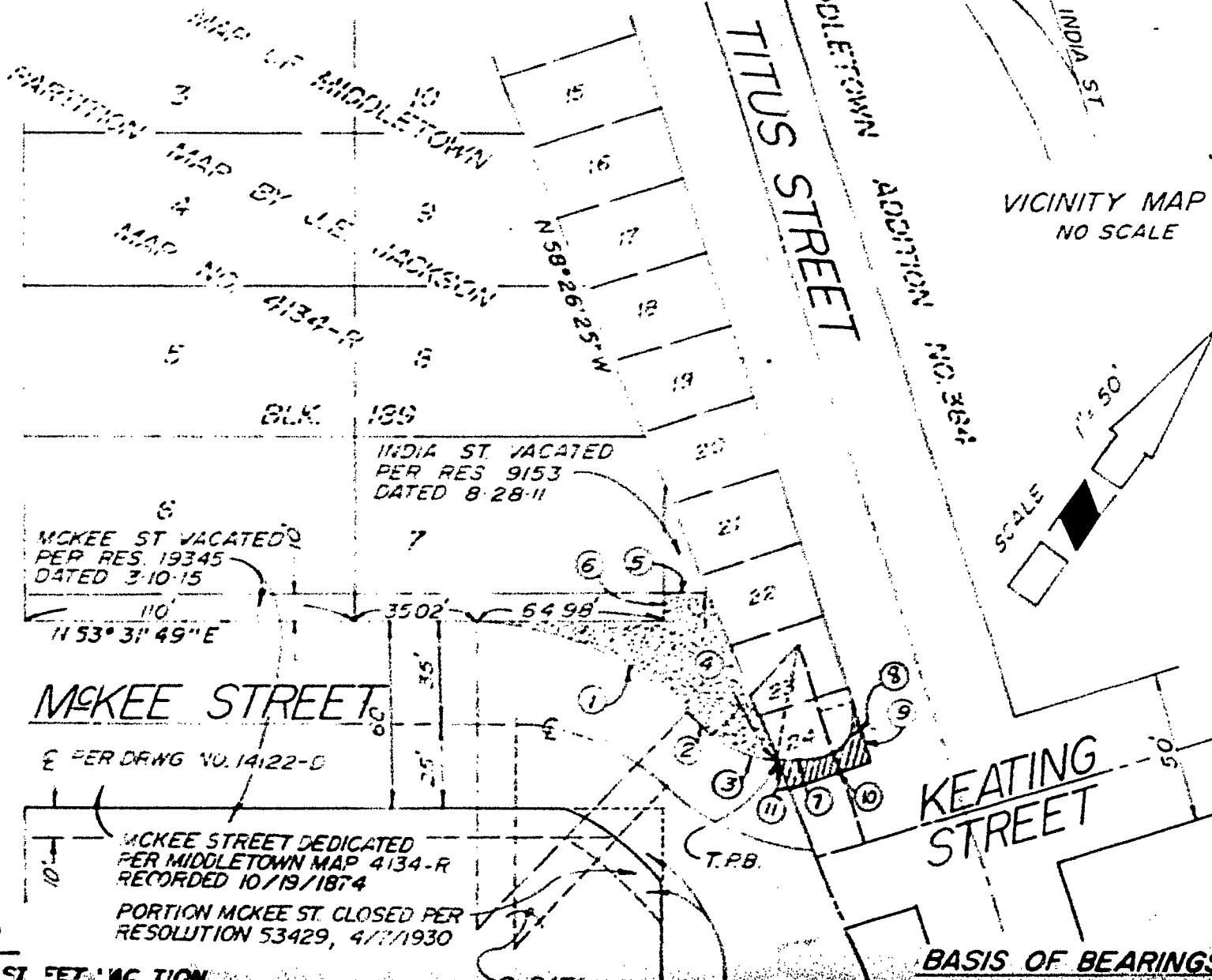

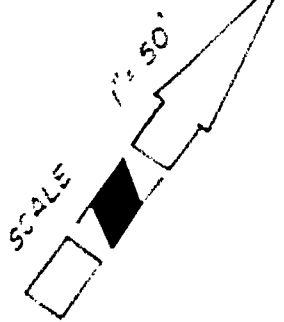

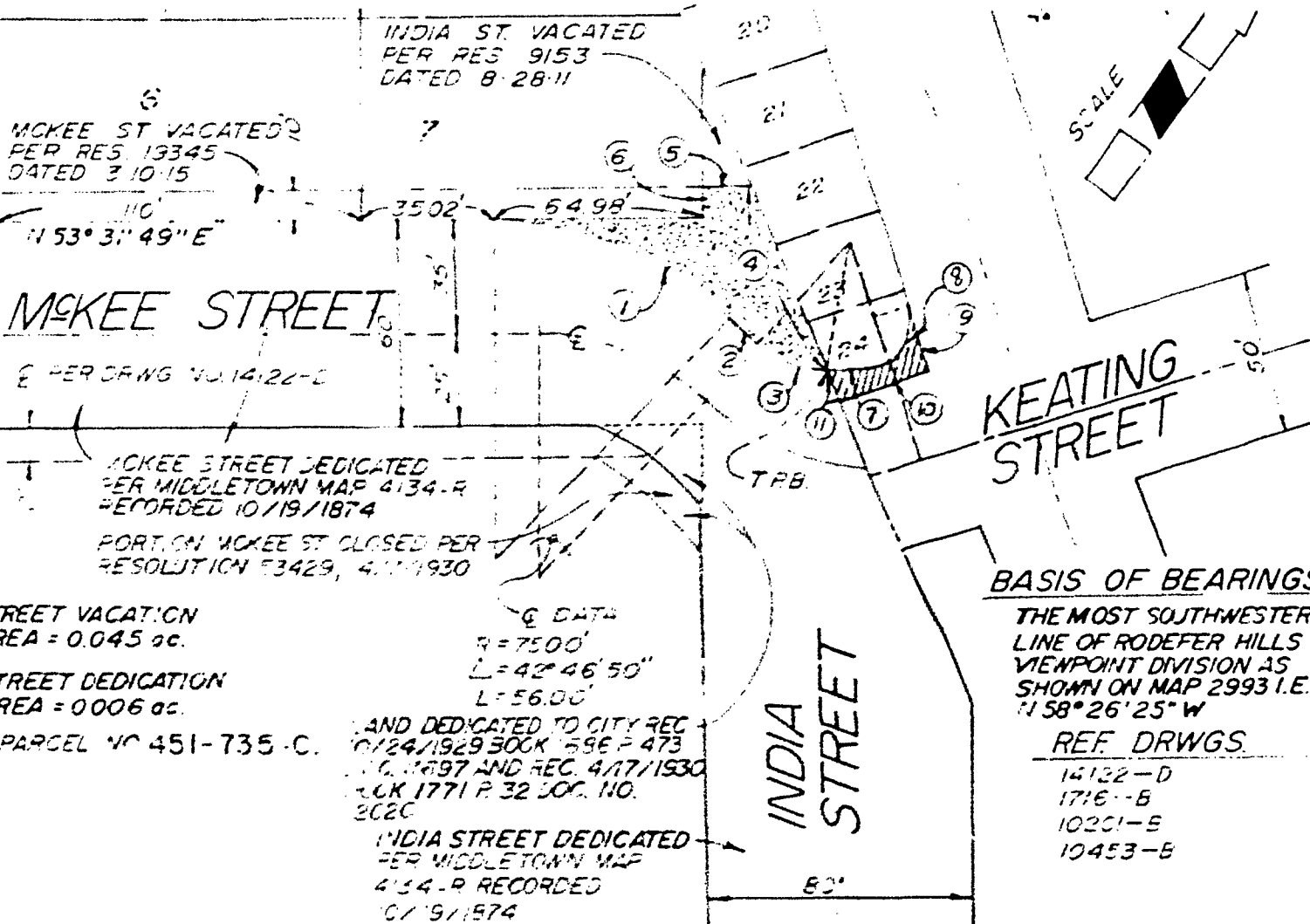

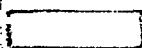
