
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Grant Deed of JULIUS HOFER, JR., ELLA SULZER, WALTER RUDOLPH HOFER, II and HEIDI MARIE HOFER, executed in favor of The City of San Diego, bearing date of October 1, 1980, conveying to said City all that portion of Lots 54 and 55 of Nestor Acres according to Map thereof No. 1768, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named CORONADO AVENUE. BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$215,000.00 from Capital Outlay Fund 3245 for said acquisition, relocation and related costs for this project, is hereby authorized and approved.
