

RESOLUTION NO. R-253159

WHEREAS, because of a high water table and flooding, TMY FARMS has been unable to utilize approximately 61.74 acres in size, which property is included in the SAN PASQUAL VALLEY lease to TMY FARMS on March 13, 1978; and

WHEREAS, TMY FARMS has requested that said property, known as PARCEL A, be deleted from its leasehold; and

WHEREAS, the City Manager concurs and recommends that the property be deleted so that it can be combined with an adjacent parcel to be offered for lease for dairy or other purposes; NOW, THEREFORE,

BE IT RESOLVED, that the City Manager is hereby authorized and empowered to execute a document deleting PARCEL A consisting of 61.74 acres from the TMY FARMS leasehold, a copy of which document is on file in the office of the City Clerk as Document No. RR-253159.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to grant a credit to TMY FARMS in the amount of \$7,460 representing back rent on said parcel, in view of the fact that TMY has been unable to utilize the parcel since the inception of its lease, but that said \$7,460 shall be held by the City pending the resolution of an existing lawsuit between TMY FARMS and the City.
