
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That Change Order No. 1, dated October 15, 1980, heretofore filed with the City Clerk of said City as Document No. RR-253161, issued in connection with the contract between The City of San Diego and Horizons Construction Company for the CONSTRUCTION OF EVANS STREET STORM DRAIN BETWEEN IMPERIAL AVENUE AND COMMERCIAL STREET, said contract having been filed in the office of the City Clerk as Document No. 251838, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$7,000, and an extension of time of two working days, extending the completion to 62 working days, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer the sum of \$3,000 from the Capital Outlay Unallocated Reserve, C.I.P. 90-245 to C.I.P. 11-158, Evans Street Drain.

BE IT FURTHER RESOLVED, that the expenditure of \$3,000 is hereby authorized from C.I.P. 11-158, Evans Street Drain, solely and exclusively for this purpose.
