BE IT FURTHER RESOLVED, that Resolution No. R-250178, adopted on September 10, 1979, be revised to read as follows:

That the expenditure of \$800,000.00 out of Capital Outlay Fund 30245 of the City of San Diego be hereby authorized, solely and exclusively, for land acquisition at the Lake Murray, Cowles and Fortuna Mountain Regional Park.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$350,000.00 previously authorized by Resolution No. R-250178 for Development at the Paradise Hills/South Bay Terraces Neighborhood Park site to the appropriate reserves.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to increase CIP 23-386 Paradise Hills/Bay Terraces Community Athletic Area by the amount of \$350,000.00 from PSD Funds 11701 (\$89,461.00); 15670 (\$24,295.00) 15700 (\$110,203.00); 15701 (\$103,888.00); 15702 (\$6,340.00); 15703 (\$15,620.00) and 15710 (\$193.00).

BE IT FURTHER RESOLVED, that the expenditure of \$76,735.00 from Environmental Growth Fund 10505, CIP 23-386 Paradise Hills/Bay Terraces Athletic Area; \$89,461.00 from PSD 11701; \$24,295.00 from PSD 15670; \$110,203.00 from PSD 15700; \$103,888.00 from PSD 15701; \$6,340.00 from PSD 15702; \$15,620.00 from PSD 15703 and \$193.00 from PSD 15710 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
