

RESOLUTION NO. R-253187Adopted on NOV 25 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Robert G. Wielage	Water Utilities	\$ 50	Mr. Wielage is a Plant Operator in the Quality Division. He suggested that steps, catwalk and railing be installed around digester compressor housings at the Pt. Loma Plant. Savings could not be calculated, but this was considered to be a significant safety improvement.
David A. Buck	Fire	\$ 25	Mr. Buck is a Fire Engineer. One year ago he earned a \$25 award for his suggestion to post revised signs at Fire Stations. One year's experience has shown the new signs to be significantly more effective than the old signs. This is the remainder of Mr. Buck's award.
Alvin I. Jenkins	Park and Recreation	\$ 25	Mr. Jenkins is a Recreation Facility Caretaker. One year ago he earned a \$75 partial award for his suggestion to use vinegar as a cleaning agent. One year's experience has shown a total savings of \$992. This is the remainder of his award.
William C. Adams	Fire	\$ 25	Mr. Adams is a Fire Engineer. He suggested that a tool control program be implemented for the Fire Department. This is expected to save \$3,000 in the first year of use. This is a partial award pending a final 12-month review.
Harold F. Keezer	Fire	\$ 25	Mr. Keezer is a Fire Engineer. He suggested that photoelectric cells be installed on overhead garage doors to prevent the premature closing of doors. This is expected to save \$3,500 in repair costs annually. This is a partial award pending a final 12 month review.
