WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Francis M. Ramsey	General Services	\$ 20	Mr. Ramsey was an Electronic Technician in the Communications and Electrical Division at the time of his suggestion. He suggested that identification tags be revised for a better display of information. Savings could not be calculated, but this was considered to be a significant operational improvement.
Anne Rafferty	Water Utilities	\$ 20	Ms. Rafferty is an Intermediate Clerk in the Services Division. She suggested that place cards be used to replace error messages when messages are out of the file. Savings could not be calculated, but her suggestion was considered to be a significant operational improvement.
Richard A. Leap	Fire	\$ 20	Mr. Leap is a Fire Fighter. He suggested that two open-ended wrenches be attached to Hurst rescue tools to disconnect improperly connected hydraulic circuits. Savings can not be calculated, but this was considered to be a significant safety improvement.
Delorese J. Shafer	Risk Management	\$ 20	Ms. Shafer is an Intermediate Typist. She suggested that open enrollment announcements be broadcast on the teletype for Fire Department employees. This could not be done due to F.C.C. regulations, but a bulletin will be published and read at roll call. This was considered to be a significant operational improvement.
